Subject: Facilitated Board Workshop to Discuss the District's Fiscal Year 2014 Strategic

Plan and Work Program Development

## **Action Requested**:

It is requested the Board participate in a facilitated workshop to discuss the operating landscape in which the District finds itself; reflect on what has been achieved to date; and look to the long-term future, with emphasis on the next two years in regard to projects, transit, and fund development.

## **Background:**

The first Board workshop on strategy and desired goals, four years ago, set the stage for the work program actions the District has been following. Staff was directed to have in motion the project planning and development process for all the major projects identified:

- US 50 realignment at the south state line
- SR 89 realignment at Tahoe City
- Nevada Stateline to Stateline Bikeway, and
- Alternatives analysis for waterborne transit

The Board's strategy was for the District to "fill the gap" on project development, foster transportation implementation through partnerships and proactive leadership, and to provide a valued service to its partners.

Two years ago, the second workshop was held to address the next two years. At that time, the District added the operation of the transit system at the south shore to the work program, along with the capital projects. The workshop focused on setting the strategic direction to develop the funding needed for both projects and future transit needs, given the changing political picture for transportation funding. The emphasis was on a long-term approach to build the case representing the District's and Tahoe's transportation needs at the state level, and develop a possible Trans Sierra Transportation Coalition to advance Tahoe's prospects for transportation funding.

This year's strategic planning session will be focused on continuing the progression of fulfilling the District's authority through its capital and transit programs, with particular emphasis on regional transit and funding source development.

## **Discussion:**

The District continues to enact the strategy articulated at its last workshop. With the accomplishments to date and with the current political and economic circumstances, it is time to assess the new opportunities and obstacles that exist, and determine the desired next steps, looking ahead two more years and beyond.

The workshop will be a facilitated discussion led by Gladys Cornell of AIM Consulting, who assisted the District with the US 50 Business Review Committee. It is scheduled to be held from 9:00 a.m. to 1:00 p.m., with lunch to be provided to the Board. Please come prepared to think regionally with the long view in mind, and with the next two years as another step along that path, including shaping next year's work program, budget, and action roles for both Board and Staff.

Staff will bring the draft work program and budget to the Board in May for review and request final approval at the June meeting.

## Fiscal Analysis:

As noted, this workshop will help shape the budget proposal for the next fiscal year and lay the groundwork for the second fiscal year as well.

## **Work Program Analysis:**

As noted, this workshop will help shape the work program priorities that will correspond to the proposed budget.
