### **TRAIL AND TRANSPORTATION ISSUES TO BE ADDRESSED AT OPEN HOUSE, JAN. 19**

*“The Road Ahead for Lake Tahoe” Agenda Includes Plan for Stateline – US 50 Transit Loop,  
Tahoe Lakeview Trail Access*

**Jan. 2010** (*South Lake Tahoe, Calif.*) – The Tahoe Transportation District (<http://www.tahoetransportation.org>) is partnering with several regional agencies to host an Open House forum on Wed., Jan. 19, with agenda items including the Stateline – US 50 Transit Loop and other community projects to reinforce the connection between area trails, roads and transit.

**What:** Free event for community members to learn about and offer input on upcoming trail and transportation development in South Lake Tahoe.

**Who:** Local residents are invited to meet representatives from the Tahoe Transportation District and project partners from federal, state, county, sustainability and engineering agencies.

Event co-hosts include: BlueGo, Caltrans, California Tahoe Conservancy, City of South Lake Tahoe, Douglas County, El Dorado County, HDR, Tahoe Metropolitan Planning Organization, Tahoe Regional Planning Agency, United States Forest Service and Wood Rogers.

**When:** Wed., Jan. 19, 2011 from 5pm to 7pm.

**Where:** Lake Tahoe Community College Theatre Foyer at 1 College Dr., South Lake Tahoe, Calif. Parking is available at the main entrance.

Members of the North Lake Tahoe Community are welcome to attend a similar Open House on Thurs., Jan. 20 from 5 p.m. to 7 p.m. at the Tahoe City Public Utility District which will highlight topics of the Fanny Bridge and Roadway Project and the Tahoe Lakeview Trail. The
